Approval Transfers

Seemingly simple transfers contain hidden traps

Many companies have recently been asked by the ERCB to transfer approvals for waterfloods and recovery schemes into their own names. While initially seeming to be a simple one-page request, many companies are surprised to see the approvals stricter than they were when the transfer request was made.

Approval transfers are used to pass an enhanced recovery scheme – such as a waterflood – from one company to another. Approval transfers have been mostly ignored over the past few years, though approval schemes are not transferred automatically when the well licence is, and many companies are finding that their waterflood approvals are in a predecessor's name.

Recently, the ERCB has been more conscious of enforcing voidage replacement ratios for waterfloods and other recover schemes. However, they feel that they can't enforce restrictions unless the approvals are in the current licensee's name, and have been sending letters to many operators asking them to move the approvals into their own name.

Companies have been fairly willing to make these approval transfer applications thinking that these applications are easy one-page applications, resulting in a record number of 59 new approval transfers registered in December 2008. The usual volume is typically one or two a month.

However, upon receiving the approval transfer from the ERCB, many companies are finding changed, stricter restrictions.
